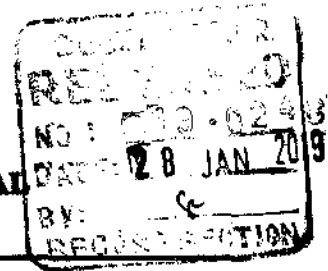

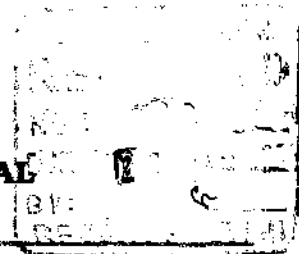

CYBERSAFETY IN SCHOOLS TRAINING

1. As announced by Atty. Josephine G. Maribojoc, Assistant Secretary/Officer-in-Charge, Office of the Undersecretary for Legal Affairs, Department of Education, there will be a Cybersafety in Schools Training for Batch Region VII on January 30 to February 1, 2019 at Golden Prince Hotel, Acacia Street, Cebu City.
2. Each Division shall send participants which will be composed of the following:
 - a) One (1) personnel from the School Governance and Operations Division, specifically the person in charge of Human Resources;
 - b) One (1) Elementary School Master Teacher on Edukasyon sa Pagpapakatao; and
 - c) One (1) Secondary School Master Teacher on Edukasyon sa Pagpapakatao.
3. Participants who have successfully completed the training shall be designated as Trainers on Cybersafety and are expected to cascade their learnings from the training to their respective Divisions. It is requested that the Division shall select participants who are familiar with the Internet and social media and have the expertise and leadership skills to train other school and Division personnel.
4. All Divisions are requested to submit the names of their participants on or before January 23, 2019 using the attached Confirmation Slip through e-mail at childprotection@deped.gov.ph copy furnished region7@deped.gov.ph.
5. Travel and other incidental expenses incurred by the participants are chargeable against local funds subject to the usual accounting and auditing rules and regulations.
