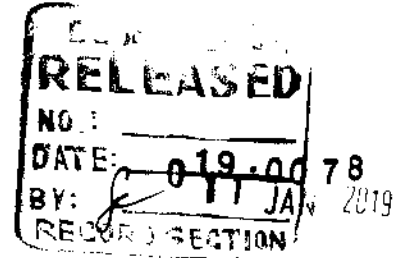


Madam:


