The Department of Education (DepEd) through the Bureau of Curriculum Development, Curriculum Standards Development Division, will conduct the **Consultative and Development of Policy on Curriculum Exits** on August 5-9, 2019 at BP Makiling Hotel, Los Banos, Laguna.

The workshop aims to:

- a. present the initial data from the Senior High School Tracer Study and other relevant information pertaining to SHS Curriculum Exits,
- b. gather inputs from different representatives regarding the Senior High School Curriculum Exits; and
- c. draft policy guidelines on the implementation of programs that focuses on guiding the Senior High School learners in the realization of their curriculum exits

Each region shall send two (2) representatives: One (1) Education Program Supervisor In-Charge of Senior High School and one (1) Regional Guidance Counselor / Advocate In-Charge of Senior High School.

All expenses relative to the conduct of the workshop including board and lodging, supplies and materials, and other incidental expenses shall be charged against 2019 BCD-BEC funds. Travelling expenses of participants will be downloaded to the respective regions subject to the usual government accounting and auditing rules and regulations.
