THREE-DAY DIVISION SEMINAR WORKSHOP ON THE CONTEXTUALIZATION OF MTB-MLE CURRICULUM MATERIALS AND ALIGNMENT OF THE CURRICULUM GUIDE

1. There will be a Three-Day Division Seminar Workshop on the Contextualization of MTB-MLE Materials and Alignment of the Curriculum Guide (phase II) on February 26-28, 2019. (venue to be announced later).
2. The training aims to:
 - a. To discuss MTB-MLE Curriculum Guides and its Budget of Work in the second quarter
 - b. To prepare and demonstrate contextualized lesson plan in MTB.
 - c. To appreciate the importance of teaching MTB-MLE class in the development of skills towards learning.
3. Participants to this training are the District MTB Coordinators and one (1) grade teacher representative per District. They are required to bring a copy of the Curriculum Guide, Teachers Guide and Learner's material in MTB from Grade 1 to Grade 3, laptop and extension wire. (see attached list of trainers)
4. Registration will start at 7:00 A.M. on February 26, 2019 followed by an opening program at 8:00 A.M. Check in will be February 26, 2019 and check out is February 28, 2019, after breakfast. **First meal to be served will be breakfast of February 26, 2019 and the last meal is afternoon snacks of February 28, 2019.**
5. Expenses for board and lodging and training materials are chargeable against HRTD Funds. Transportation and other incidental expenses of trainers, and participants will be charged against School MOOE Funds. All expenses incurred relative to the training are subject to the usual accounting and auditing rules and regulations.
