ILLEGITIMATE FEES AND COLLECTIONS BY PRIVATE SCHOOLS

To: Schools Division Superintendents/Officers-in-Charge
Assistant Schools Division Superintendents/Officers-in-Charge
CID/SGOD Chiefs
Heads, Private Elementary and Secondary Schools

1. This Office has been receiving complaints from parents anent the undesirable collections made by some private schools which are not included in the schedule of fees as confirmed and approved by this Office.
2. Be it noted that any amount or fee collected by the school from the parents outside of the confirmed schedule of fees is considered illegitimate and violation to the restriction set forth by this Office in the approved application for tuition and other school fees; which reads "*xxx the school can collect fees only for items included in the above listings and for amounts not higher than those indicated*".
3. Thenceforth, any private school complained of such undesirable activity shall be made to answer allegations relative to it.
4. Wide dissemination of this Memorandum is desired.
