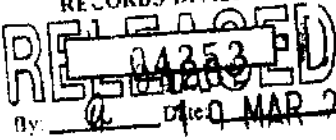

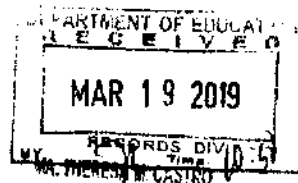

- B. **EARLY BEGINNINGS OF PFTEC**

- The pronouncement made was in response to the Cooperative Code, Article II of the Republic Act No. 6938
- In 1994, school officials and members of organized teachers' and employees' cooperatives all over the country conducted a conference in Dumaguete City led by Dr. Metodio M. Gapasin
- It was intended to bring together leaders of existing teachers' cooperatives to forge the creation of a federation of teachers' and employees' cooperatives.
- And this federation shall provide the center for a network of teachers' cooperatives nationwide. The conference led to the establishment of the Philippine Federation of Teachers and Employees Cooperatives (PFTEC).

**What is PFTEC?**

- PFTEC is an autonomous association of school-based coops united voluntarily to meet their economic, social, and cultural needs and aspirations through a jointly owned and democratically controlled enterprise.
- Though it is a secondary organization, it empowers members in DepEd regions to group together for purposes of representation in the PFTEC Membership Council (Board of Directors).
