Pursuant to DepEd Order (DO) No. 55, s. 2016 also known as the **Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program**, the Department of Education (DepEd), through the Bureau of Education Assessment (BEA), issues the **Schedule of the Administration of National Assessment of Student Learning for the K to 12 Basic Education Program**.

2. The DepEd's administration of various National Assessments are as follows:

Testing Programs	Schedule of National Administration
Early Language, Literacy and Numeracy Assessment	Three weeks after the first day of classes
National Achievement Test for Grades 6 and 10	Three weeks after the first day of classes
Basic Education Exit Assessment for Grade 12	Third week of the second semester
National Career Assessment Examination	Last Wednesday and Thursday of August
Philippine Educational Placement Test	Luzon Cluster-Third Sunday of November Visayas and Mindanao Cluster- Fourth Sunday of November

3. Changes in the schedule of test administration of all testing programs will be announced through the issuance of an Advisory.

4. The Division Testing Coordinators (DTCs) are reminded of the following:

- Guidelines in test administration will be discussed in the National Conference; and
- For PEPT, the number of examinees per school/testing center should be submitted to BEA forty days prior to the test administration using the matrix below:
