Adherence to DepEd Order No. 49 s. 2009 "Revised Rules and Regulations on the Teaching of Religion in Public Elementary and Secondary Schools", DepEd Order No. 9, s. 2005 entitled "Instituting Measures to increase Engaged Time-on-Task" and DepEd Order No. 39, s. 2009 entitled "Strict Adherence to DepEd Order No. 28, s. 2001 Prohibiting the Commercialization of the DECS Organization through Endorsements and Accreditation of Goods and Services"; and
- c. Participation of the learner is purely voluntary. There shall be no collection of fees.
