- The One Health Week shall hold activities that focuses on the six flagship programs of the School Health Section:
 - a) School-Based Feeding Program (SBFP);
 - b) National Drug Edition Program (NDEP);
 - c) Adolescent Reproductive Health Program (ARH);
 - d) Water, Sanitation and Hygiene (WASH) in Schools (WinS) Program;
 - e) Medical, Dental and Nursing Services; and
 - School Mental Health.
- 3. The One Health Week shall be maximized to mobilize the community and promote collaboration with partners and stakeholders especially at the school level. As such, schools are tasked to link with stakeholders within their localities for various health endeavours such as the improvement and maintenance of health facilities; provision of health and nutrition services; and finalization of deliverables and schedule of joint health activities for the school year. Schools should coordinate with their Division Health Personnel for the conduct of the activities. During the One Health week, all public elementary and secondary schools are enjoined to undertake the following suggested activities:
 - a) Orientation of parents, communities, partners and stakeholders;
 - b) Delivery of age-appropriate health services:
 - c) Launching of age-appropriate health and hygiene practices;
 - d) Conduct of feeding activities and school gardening activities;

- Pursuant to Department of Education Order No. 28, s. 2018 titled "Policy and Guidelines on Opian Kalusugan sa Department of Education (OK sa DepEd)." all public schools are enjoined to observe a nationwide OK sa DepEd One Health Week on July 22-26, 2019. The National Kick-Off for OK sa DepEd will be on July 24, 2019 at Banisil Elem. School, General Santos City and to be spearheaded by the Bureau of Learners Support Services-School Health Division. The One Health Week will roll out health activities giving focus on the six Major Flagship School Health Programs:
 - 1) School-Based Feeding Program
 - 2) National Drug Education Program (NOEP)
 - 3) Adolescent Reprodcutive Health Program (ARH)
 - 4) Water, Sanitation and Hygiene (WASH) in Schools (WinS) Program
 - 5) Medical, Dental and Nursing Services
 - 6) School Mental Health Program

During the One Health Week, Schools Division Offices, elementary and secondary schools are enjoined to undertake the following suggested activities:
 - 1) Orientation of parents, communities, partners and stakeholders;
 - 2) Delivery of age-appropriate health services (medical, dental & nursing services)
 - 3) Launching of age-appropriate health and hygiene practices;
 - 4) Conduct of feeding activities and school gardening activities;
 - 5) Exhibits/for a on the NDEP, ARH, school mental health and comprehensive tobaccocontrol:
 - 6) Open house of canteens featuring healthy food and beverage choices:
