I. STATEMENT OF PURPOSE

Pursuant to Proclamation No. 683, s. 1991 entitled "Declaring the Month of February of Every Year as National Arts Month," this memorandum is issued to enjoin all Regional Directors in support of the celebration of the National Arts Month (NAM) of 2019.

The harvest of the diversity of expressions can be part of values education for patriotism, forging cultural identity and love of country, and affirming a heritage of defending a freedom legacy. This celebration aims to awaken pride of place, heritage, history, and language that will promote social justice and peace with the will to secure freedom from poverty.

II. OBJECTIVES

In general, the observance of this event has four (4) objectives:

- 1) Promote and popularize the outstanding creations of Filipino artists in the seven arts for all sectors both local and international;
- 2) Promote the integration of arts in community life;

- 3) Underscore the significant role of art and artist and other stakeholders in uplifting the nation's spirit; and
- 4) Utilize art as a catalyst for values education.

III. FOCUS

For the year 2019, *Ani ng Sining: Philippine Arts Festival* shall underscore and highlight the following:

- 1) Creative power of the arts and its role as a catalyst for change;
- 2) Arts as a reflection of the nation's soul, and from it our pride of being Filipino; and
- 3) Fruits of the creative efforts for the past year and a looking forward to a richer, more fertile ground in the coming years for the evolution of artistic modes of expression available to the Filipino creative imagination.

Depending on the focus and direction of its art activities, an agency, region, province, city, and municipality may choose to have its own theme that is most relevant to their local culture, arts and community aspirations.

IV. SUGGESTED ACTIVITIES

Activities may be undertaken by the agency or institution in accordance with its own capabilities. These may be in the form of music, dance or theater performances, film screening or visual arts exhibits visits to museums or cultural sites, or any other forms relevant to the theme and selected sub theme of the agency, organization, Local Government Unit (LGU). Below are some suggested activities:

- 1) Contemporary creative expression of the local artists through but not limited to: productions, exhibitions, film screenings, book launching, and poetry readings etc.;
- 2) Cultural exchange/artist interaction to the general public;
- 3) Recognition of local artists;
- 4) Feature works of the national artists;
- 5) Feature the works of a local *Ani ng Dangal* Awardee;
- 6) Exhibition of local creative industries;
- 7) Promotion local art practices/tradition unique to the region;
- 8) Art workshop/appreciation activities;
- 9) Collaborative work of various art forms/groups;
- 10) Showcase of fruits of the creative efforts for the past year (restaging of past production, exhibitions, film screening etc.);
- 11) Promotion of local cultural icons based on NCCA's *Sagisag Kultura ng Filipinas*;
- 12) Cultural awareness seminar workshop to local artists, art organizations, leaders and LGU staff; and

- 13) Special art program for the marginalized group in the community (Out-of-School Youth (OSY), Persons with Disabilities (PWDs), senior citizens, indigenous peoples, women and children).

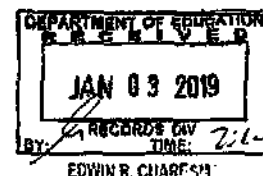
