The District Supervisor and 2 School Heads shall be selected by the SDS. The prioritization in the selection process is as follows:

1. District Supervisor/School Head is assigned in both a conflict-affected and IPED-implementing school;
2. District Supervisor/School Head is assigned in conflict-affected school only; or
3. District Supervisor/School Head is assigned in an IPED-implementing school only.

Accommodations will be from November 12-14, with the first meal is dinner on November 12, 2019 while the last meal will be breakfast on November 15, 2019. Travel expenses of IPED Regional/Division Focal Persons shall be charged to Regional/Division 2019 IPED Support Funds; for other participants, this shall be charged to local funds.
