Traveling expenses and board and lodging of the awardees and other incidental expenses shall be charged against 2019 ALS funds subject to the usual government accounting and auditing rules and regulations.

**Guidelines for the Selection of 2019 National Recognition for Exemplary
DepEd-Delivered ALS Teachers**

I. Background

The ALS program implementation is primarily delivered by the ALS Mobile Teachers and District ALS Coordinators (DALSCs) who conduct community-based learning sessions to out-of-school children, youth and adults (OSCYA) in geographically isolated, disadvantaged, marginalized, and sometimes conflict-affected areas and communities. In consideration of their contribution to the delivery of quality ALS programs, the Department of Education (DepEd) through the ALS Task Force will give due recognition to select DepEd-Delivered ALS teachers starting this year. This activity is expected to help boost the morale of other ALS teachers.

II. Awards Objective

To give due recognition to select DepEd-Delivered ALS Teachers (Mobile Teachers, Full-Time District ALS Coordinators) for their exemplary performance, dedication and outstanding achievements in the promotion of literacy and quality education in Alternative Learning System (ALS).

III. Mechanics

General Guidelines

1. The recognition is open to all DepEd-Delivered ALS Teachers (Mobile Teacher, Full-time DALSC) who superbly show their exemplary performance, dedication and outstanding achievements in the promotion of literacy and quality education in Alternative Learning System.
2. He/she has rendered service as ALS teacher for 5 years and above.
3. The Schools Division Offices shall select one of their best ALS DepEd-Delivered to be endorsed to the region. The Regional Office shall select one of their best ALS teachers to be endorsed to the Central Office. All endorsements shall be supported with the required documents duly signed by their Schools Division Superintendents and Regional Directors.
4. There shall only be one (1) awardee per region, and the documents of the Regional Awardee shall be endorsed by the Regional Director as cover letter to be submitted to Dr. Manlette R. Almayda, Director III, Head, ALS Task Force, **on or before November 22, 2019**, and addressed to the ALS Task Force Office, 5th Floor Bonifacio Bldg., DepEd Complex, Meralco Ave., Pasig City

Criteria for Judging

Selection of best DepEd-Delivered ALS Teachers shall be based on the following criteria:

- A. Potential - 40%

B. Impact on Learners

Enumerate and describe the notable effects of the nominee's performance on the Life of the Learners.

(Attached learner's pictures with the nominees, statistical data on the learner's gains, signed Testimonies of the learners to prove the nominee's effectiveness in implementing ALS programs that has impact in the life of the learners.)

Note: Signed Testimonies written in mother tongue should be translated in English or Filipino by the awardees.
