Dear Ma'am Bongalos:

This pertains to your resubmitted request of SARO and NCA to cover the payment of Monetization of Leave Credits (MLC) of 247 personnel in the amount of ₱18,929,848.47.

Per latest advisory from DBM Central Office, request for this purpose may be processed, provided that the reason for MLC falls within the purview of the following criteria:

- a. Health, medical and hospital needs of the personnel and/or immediate members of his/her family ; and
- b. Requirements for financial aid and assistance brought about by force majeure events, such as calamities, typhoons, fire earthquake and accidents.

Based on our evaluation, there are personnel that must be excluded since their reasons do not fall within the above-mentioned criteria. For the qualified personnel, their justification letter must also be submitted to support their request.

In view of the foregoing, we are returning the request with all the supporting documents without prejudice to its resubmission upon compliance of the required documents/deficiencies.
