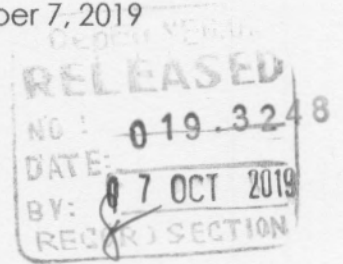

To ensure a smooth conduct of this activity, all member agencies/offices are requested to prepare the following:


1. Proposed programs, projects, services and/or activities (PPSA) with corresponding funding requirements using the attached template; and
