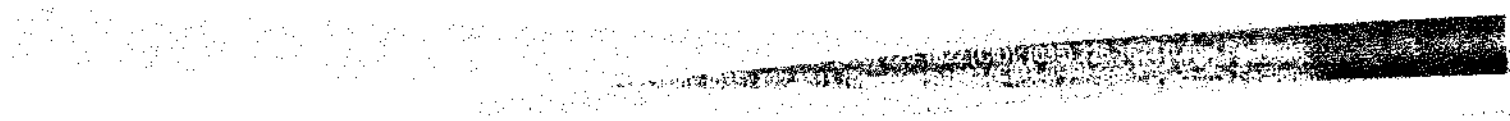

4. Arrival and check-in is on **November 5, 2019**. Registration of participants starts at 1:00 pm (lunch will be served), and hotel check in is at 2:00pm.
5. They are expected to arrive before lunch on November 5 in time for the Opening Program at 1:30 pm and the actual training will start immediately. Participants who will check-in before November 5 will be billed separately;
6. Check-out is on **November 8, 2019** after breakfast;
7. All participants are requested to review and bring their BFS and HACCP manuals; and
8. Traveling expenses for this activity was downloaded in compliance to Memorandum OUF-2019-0046, re: Submission of Allocation List - FY 2019 Program Support Funds (PSF) and Travel Expense Funds for Downloading.


