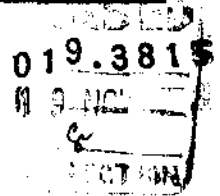



1. The Department of Education-National Employees' Union (DepEd-NEU) will hold its **13th National Congress and Seminar-Workshop** with the theme, **Dynamic Role of the DepEd-NEU Towards Sustaining the 10-Point Basic Education Reform Agenda of Secretary Leonor Magtolis Briones**, from November 26 to 28, 2019 (exclusive of travel time) at the Crown Legacy Hotel, Kisad Road, Baguio City.

2. The congress aims to

- a. provide the participants with an in-depth overview of the 10-Point Basic Education Agenda and its challenges;
- b. develop and propose appropriate programs and activities of the DepEd nonacademic rank-and-file employees relevant to the 10-Point Basic Education Agenda;
- c. raise awareness on the existing DepEd programs and projects; and
- d. strengthen DepEd-NEU's representation and participation in all committees, programs and projects of DepEd, at the central, regional, schools division offices, and school levels as an essential factor in the delivery of quality public service and agenda performance.

3. Participants to this congress are DepEd-NEU chapter executive officers and members at the regional, schools divisions and school levels, who are all nonacademic rank-and-file employees of DepEd, including but not limited to, central, regional, division, and school accountants/bookkeepers, administrative officers/ assistants/aides, attorneys, budget officers, cashiers, disbursing officers, education program specialists, engineers, guidance counselors/coordinators, human resource management officers/personnel officers, health and nutrition personnel, information and communication technology personnel, librarians, medical officers/nurses, project development officers, planning officers, registrars, special investigation officers, statisticians, supervisors, supply officers, and all other nonteaching personnel. The members of the National Board of Trustees (NBDT) and National Executive Committee (NEC), chairpersons, and members of the DepEd-NEU secretariat, and steering committees are also authorized to attend. Attendance of the participants shall be **on official business**.

4. A registration fee of Five Thousand Nine Hundred Fifty Pesos (P5,950) shall be charged to each participant to cover expenses for the kits, board and lodging, honoraria of resource persons and facilitators, and other incidental expenses charged to local funds, subject to the usual accounting and auditing rules and regulations.

5. The members of the different working committees, the NBOT, and the NEC shall be considered participants and shall pay their registration fees in full. They are authorized to travel two days before the start of the congress for the necessary preparations.

6. The deadline for confirmation and payment of registration fee shall be on or before **November 20, 2019**. Further details on the confirmation and bank account may be accessed at <http://bit.ly/2019depedneucongress>.

7. The bank deposit slip with the printed name shall be scanned and sent through email in c1772@yahoo.com. Only when a participant shall have sent through email the scanned deposit slip shall s/he be considered confirmed and registered. Official receipt from the DepEd NEU will be issued upon presentation of the original bank deposit slip at the activity venue.

8. Only those who confirmed and paid the registration fee during the deadline provided shall be assured of accommodation. Participants are advised to confirm and register as early as possible to avoid any inconvenience.

9. Validation of registration and provision of room assignments shall start at 8:00 a.m. on **November 26, 2019** and check-in of confirmed and registered participants will be at 1:00 p.m. of the same date. The first meal to be served will be lunch on **November 26, 2019**. Check-out will be on **November 28, 2019** at 12:00 noon and the last meal will be lunch on the same day.
