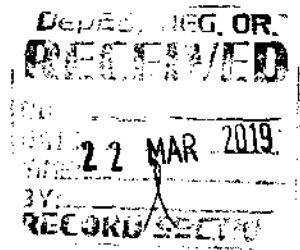

Agenda of the meeting is the normalization plan for the RPM-P/RPA/ABB-TPG for 2019-2021.


