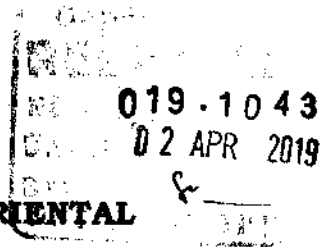

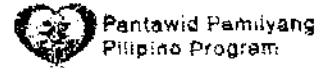
Relative to this, the monitoring and evaluation officers request for a courtesy call and visit to the following schools on April 3, 2019.
