

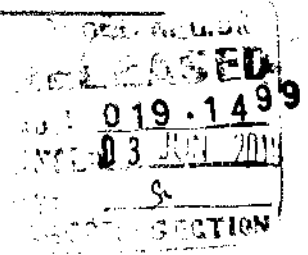

The Department of Education (DepEd) through the Bureau of Curriculum Development, Special Curricular Programs Division, will conduct the **Consultative Workshop vis-à-vis Development of National Framework on the Comprehensive Guidance and Counseling** on June 5-7, 2019 at BP Makiling Los Baños, Laguna.

The workshop aims to:

- a. Revisit the existing guidance and counseling program of public schools
- b. Discuss trends, issues, problems, best practices and opportunities related to guidance and counseling in the elementary, JHS and SHS
- c. Develop the national framework for comprehensive guidance and counseling in support to the K-12 Program

The Program of Activities and list of **official participants** for this workshop are provided in Annex A for your reference. Participants are asked to bring their own laptops, extension cords and other pertinent documents needed in the activity.

All expenses relative to the conduct of the workshop including board and lodging, travelling expenses of the participants, supplies and materials, and other incidental expenses shall be charged against 2019 BCD BEC funds, subject to the usual government accounting and auditing rules and regulations. The participants are expected to submit their complete travel documents (travel authority signed by the Regional Director, plane/bus tickets, boarding pass, terminal fee receipts, etc.), and other incidental expenses during their registration at the venue.

The participants are expected to be at the venue at 8:00 AM on June 5, 2019 with Breakfast as the first meal. The opening program will start at 10:00 AM on the same day. The last meal will be afternoon snacks on June 7, 2019. Participants have to bring their existing Guidance Program.
