Subject: **INVITATION TO THE CONSULTATION WORKSHOP ON THE
ENHANCEMENT OF PROTOCOLS ON SAFE SCHOOLS RELATING
TO ARMED CONFLICT ON 03-04 JULY 2019, PASIG CITY**

The Disaster Risk Reduction and Management Service (DRRMS) invites select representatives from regions and divisions to participate in the **Consultation Workshop on the Enhancement of Protocols on Safe Schools relating to Armed Conflict on 03-04 July 2019** at The Linden Suites, Ortigas Center, Pasig City.

Efforts in strengthening the resilience of the education sector especially in armed conflict situations are necessary due to the increasing threats of armed conflict to learners, personnel, and schools as seen in the 2013 Zamboanga Siege, 2017 Marawi Siege, and recent encounters between state and non-state armed groups.

In response to these growing threats to the Department, the DRRMS has conducted two-year nationwide consultations in conflict-affected and -vulnerable areas for the crafting of the *National Policy Framework on Learners and Schools as Zones of Peace*, which is on its final approval stage. Supplemental to this Framework, the team has produced the zero draft Protocol which aims to guide DepEd offices at all levels, including schools in preparing for, responding to, and recovering from armed conflict incidents.

Preliminary inputs and recommendations based on various consultations during the first half of 2019 were solicited from school personnel and community stakeholders as to how the draft Protocol will be beneficial, tailor-fitted, and responsive to the differing contexts and circumstances of schools in cases of armed conflict situations.

This draft Protocol will be subjected to in-depth discussions this July 2019 together with participants from DepEd Central Office, National Government Agencies, and External Partners towards its finalization. Thus, we are **inviting the following representatives from your respective regions and divisions** to provide further insights and suggestions on the document:
