

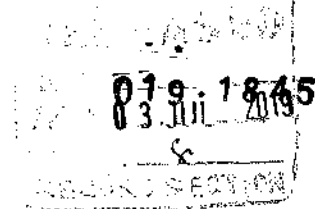

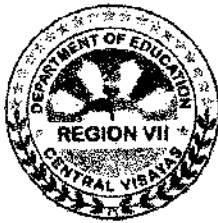


We look forward to your favorable response on said request, as we continue to support in intensifying the career advocacy program in the region.
